COMMUNITY DEVELOPMENT ANNUAL ACTION PLAN 30-DAY PUBLIC COMMENT PERIOD AND PUBLIC HEARING

Title I of the Cranston-Gonzalez National Affordable Housing Act requires that in order to apply for certain U.S. Department of Housing & Urban Development (HUD) Programs, the City of Westfield must submit an Annual Action Plan. The Annual Action Plan identifies resources and programs to be undertaken during the program year July 1, 2018 through June 30, 2019.



The draft Annual Action Plan will be available March 27, 2018 to April 27, 2018 for review and comments at the Community Development Department, 59 Court Street, Westfield, MA or online at www.cityofwestfield.org.
