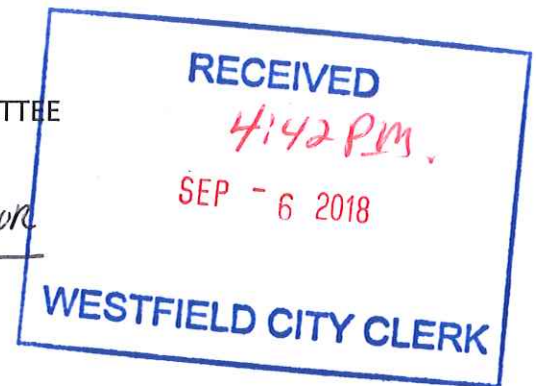

- 4) On 7-5-18, a motion by Councilor Figy that a resolution to accept a local option excise tax on the retail sale of Marijuana at the maximum allowed by statute of 3%.
- 5) On 8-16-2018, a resolution approving the appropriation of monies in the amount of \$8,000.00 from the Commission for Citizens with Disabilities Handicap General Expense account #2454400-578000 for the creation of making an accessible playground in the City of Westfield.
