Agenda Item #1

The appointment of Eileen Rockwal, 5 Blueberry Ridge, as a member of the Council on Aging for a term to expire the first Monday of February, 2021, replacing Barbara Sokolowski, resigning.

Voted 3-0 to recommend that appointment.

Discussion:

Ms. Rockwal is very interested in serving on this Board. She states she has a strong desire to give back to our Community and believes this becomes evident when seeing her past accomplishments which include being on the Westfield State University Alumni Council for 7 years, chairing the Finance Committee as well as the Awards, Scholarship and Recognition Committee. A Foundation Board Member, she is still also an Interfaith Committee member. Also, she recently has volunteered as a Pastoral Council Member at Blessed Sacrament Church.

She also shares that she enjoys being involved with people in general but became very interested in learning of the challenges for our older population from her sister who is an outreach worker for a Senior Center and that she would like to be an advocate for our seniors.

The appointment of Kerry Ann Kielbasa, 31 Crescent Ridge Road, as a member of thre Council on Aging for a term to expire the first Monday of February, 2021, replacing John Leary, Jr., resigning.

Discussion:

Ms Kielbasa states she has a passion for working with older adults and has extensive experience in the field of aging. She was responsible for the day-to-day operation of the Town of Granby, CT's Senior Center when employed by Granby as Director of Human Services from 1990 to 2015. During that time she was involved in designing and building a new Senior Center and initiated numerous programs and services to enhance the quality of life for Seniors including benefit counseling, transportation, meal programs, social service programs, supervising staff and volunteers and preparing an annual budget.

She also served on the Phase 2 Building Committee for our Westfield Senior Center, wants to continue to serve in a vital role involving the Center, and believes she would able a "good fit."

She has an MBA and is affiliated with many memberships regarding Seniors and continue to serve as a National Peer Reviewer for Accreditation for the National Council on Aging.

Discussion:
