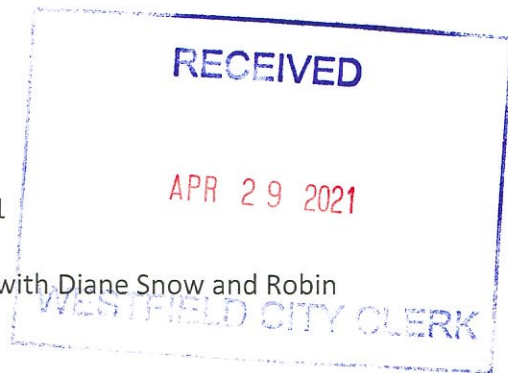


Westfield Board of Assessors
