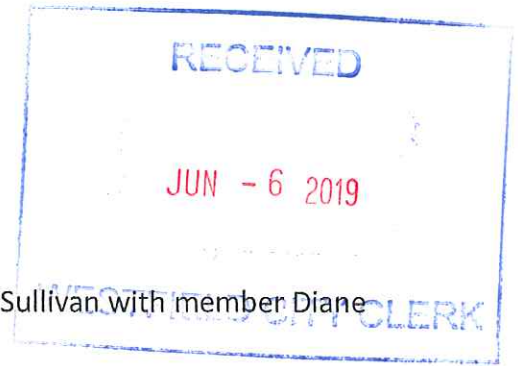


WESTFIELD BOARD OF ASSESSORS

However, the building is not open to the public yet and the legal department determined that we cannot approve the application. This is the same ruling that was determined last year. The Board discussed their options at this time as they disagree with the legal ruling.

New Business:



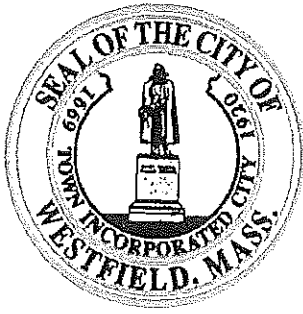
