OTHER DEADLINES (Non-Hearing Matters)

- ✓ **SUBDIVISION FORM A ('ANR' Plans)** - An executed Form A, fee and plans must be received no later than the Wednesday prior to the meeting for which Board endorsement is desired. Late submissions may be considered if the Planning Office is contacted before the subject final meeting agenda has been posted.
- ✓ **SUBDIVISION FORM B (Preliminary Plan) & FORM F (Release Request)** - Required documentation should be filed at least 10 business days prior to the meeting date at which Board action is desired.
- ✓ **OTHER PLANNING BOARD BUSINESS** - Contact the Planning Office or Chair with an agenda item request sufficiently in advance (as appropriate to the complexity of the matter) for consideration, but no later than the Wednesday prior to the meeting.
- ✓ **PUBLIC PARTICIPATION** - In addition to formal public hearings, the Board welcomes public comment on any other topic at each regular meeting; arrive promptly by 6:00 PM if you wish to so address the Board.
