**SUBSTANTIAL AMENDMENT #1
TO THE FIRST YEAR ACTION PLAN
FISCAL YEAR 2020-2021**

The City of Westfield, acting through its Office of Community Development, has proposed an amendment to the First Year Action Plan for Fiscal Year 2020-2021.

The amendment is necessary to provide public notice that a substantial change is proposed to the 2020-2021 Action Plan.

This amendment will be available for public comment for no less than five days, consistent with the City's Citizen Participation Plan Emergency Waiver as allowed by The Coronavirus Aid, Relief and Economic Security Act (CARES Act) (Public Law 116-136).

Summary

The proposed amendment is detailed in an accompanying chart.

Amendment #1: Neighborhood Revitalization Project activities have been amended in the following manner:

-To remove reference to "INFRASTRUCTURE- SIDEWALKS/NEIGHBORHOOD TBD" and "KASPER DRIVE RESURFACING" and replace with "CROSS STREET PUBLIC PARKING LOT RECONSTRUCTION AND SIDEWALK INSTALLATION."

The Office of Community Development will hold a virtual public hearing on **Wednesday, July 23, 2020, at 6:00 pm, at Westfield City Hall, 59 Court Street, Room 206, Westfield, MA 01085** to accept public comment on the proposed amendment.
